Event Waiver Release and Indemnity November 9th, 2013 Abaco, Bahamas

Physical Condition: I declare and warrant that I am physically fit to participate in the Kayak Challenge (“the Event”) in which I have chosen to participate, and have not been advised otherwise by a medical practitioner.

Course Inspection: I agree that, before I participate in the Event, I will inspect the course and general conditions for the Event. I will immediately advise the supervisor of the Event of any unsafe condition that I shall observe. I will refuse to participate in the Event if I consider that any unsafe conditions shall exist.

Assumption of Risk: I understand and acknowledge that I, and each participant in the Event, shall be engaging in activities that involve the risk of serious injury, illness, permanent disability, dismemberment and death, and that also involve the risk of economic and property loss and damage. I understand that these risks may result from the actions, negligence or failure to act of myself and others (including but not limited to other participants in, and the sponsors, organizers and volunteers of the Event) or from the rules applicable to the Event, or the challenges of the event or the condition of the course, facilities or equipment used. I also understand that there may be risks involved which are not known to me or the sponsors, organizers, and volunteers, and may not be foreseen or reasonably foreseeable by any of us at this time or at the time of the activities in which I may participate. I assume all of the foregoing risks including the risk of any negligence by other participants or by anyone in the community in which the event shall occur, the organizers, sponsors, or volunteers of the Event and their respective owners, directors, officers, employees, or agents, and the risk of injury caused by the condition of any property, facilities, or equipment used during the Event and accept personal responsibility for any injury (including, but not limited to personal injury, disability, dismemberment and death), illness, damage, loss, claim, liability, or expense, of any kind or nature, that I or my property may suffer arising out of or in connection with the Event or my participation therein or my attendance thereat.

Liability Release: I hereby release and forever discharge and agree to save and hold harmless the Event, the organizers and promoters of the event, and their respective parents and their subsidiaries and volunteers associated or affiliated with the Event, the owners, lessors and lessees of the property, facilities and equipment used in connection with the Event, the respective organizers, directors, officers, employees, and agents of all of them, and the other participants in the Event (each such entity or individual being referred to as a “Released Party”) of and from any and all injuries (including, but not limited to personal injury, disability, dismemberment and death), illness, damage, loss, claim, action, suit or proceeding or other liability or expense, of any kind or nature (and whether accruing to me, my heirs, dependants or my personal representatives) that may be caused or alleged to be caused in whole or in part by the action, negligence, failure to act of any Released Party or condition of the property, facilities or equipment and that may arise out of or in connection with the Event or my participation therein or my attendance thereat.

Indemnity: I hereby agree to indemnify and keep indemnified the Event, the organizers and promoters of the event, and their respective parents and their subsidiaries and volunteers associated or affiliated with the Event, the owners, lessors and lessees of the property, facilities and equipment used in connection with the Event, the respective organizers, directors, officers, employees, and agents of all of them, and the other participants in the Event (each such entity or individual being referred to as a “Released Party”) of and from any loss, claim, action, suit or proceeding or other liability or expense, of any kind or nature (and whether accruing to me, my heirs, dependants or my personal representatives) claimed made or brought by any person and arising out of my action, negligence, failure to act or condition of the property, facilities or equipment in connection with the Event or my participation therein or my attendance thereat.

Medical Treatment: I understand that the emergency first aid, medication, medical treatment available at the event is extremely limited. In connection with any injury that I may sustain or other medical conditions I may experience during my participation in or attendance at the Event, I authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by any attending medical personnel if I am not able to act on my own behalf. I further authorize any attending medical personnel to execute on my behalf any permission forms, consents, or other appropriate documents relating to medical attention and to act on my behalf if I am not able or immediately available to do so.

Severability of Provisions: I agree that the foregoing agreements are intended to be as broad and inclusive as is permitted by law. Any provisions herein found by a court to be void and unenforceable shall not affect the validity

or enforceability of any other provisions.

**ACTIVE REGISTRATION AGREEMENT AND LIABILITY WAIVER
(the "Agreement and Waiver")**

1. Authority to Register and/or to Act as Agent. You represent and warrant to Friends of the Environment ("FRIENDS") that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"), including full authority to make use of the credit or debit card to which registration fees will be charged.

If you are registering a child under the age of 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties. By registering a child under 13, you agree and consent to the collection of that child's information which you provide for the purposes of registration.

2. Waiver.

YOU UNDERSTAND THAT PARTICIPATION IN THE EVENT IS POTENTIALLY HAZARDOUS, AND THAT A REGISTERED PARTY SHOULD NOT PARTICIPATE UNLESS THEY ARE MEDICALLY ABLE AND PROPERLY TRAINED. YOU UNDERSTAND THAT EVENTS MAY BE HELD OVER OPEN WATER AND AREAS ARE OPEN TO THE PUBLIC DURING THE EVENT AND UPON WHICH HAZARDS ARE TO BE EXPECTED. PARTICIPATION CARRIES WITH IT CERTAIN INHERENT RISKS THAT CANNOT BE ELIMINATED COMPLETELY RANGING FROM MINOR INJURIES TO CATASTROPHIC INJURIES INCLUDING DEATH. YOU UNDERSTAND AND AGREE THAT IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN THE EVENT, YOU AND ANY REGISTERED PARTY, THE HEIRS, PERSONAL REPRESENTATIVES OR ASSIGNS OF YOU OR THE REGISTERED PARTY DO HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE ACTIVE FOR ANY AND ALL LIABILITY FROM ANY AND ALL CLAIMS ARISING FROM PARTICIPATION IN THE EVENT BY YOU OR ANY REGISTERED PARTY.

3. Indemnification. You agree to indemnify and hold each of FRIENDS harmless from and against any and all damages, costs, claims or demands, including reasonable attorneys' fees, made by any third party due to or arising from or relating to your use of FRIENDS or the violation of any term of this Agreement and Waiver.

4. Severability. You further expressly agree that this Agreement and Waiver is intended to be as broad and inclusive as is permitted by the law of The Bahamas and that if any provision of this Agreement and Waiver shall be found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and Waiver and shall not affect the validity and enforceability of any remaining provisions.

BY INDICATING YOUR ACCEPTANCE OF THIS AGREEMENT AND WAIVER, YOU ARE AFFIRMING THAT YOU HAVE READ AND UNDERSTAND THIS AGREEMENT AND WAIVER AND FULLY UNDERSTAND ITS TERMS. YOU UNDERSTAND THAT YOU ARE GIVING UP SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE.

YOU ACKNOWLEDGE THAT YOU ARE SIGNING THE AGREEMENT AND WAIVER FREELY AND VOLUNTARILY, AND INTEND BY YOUR ACCEPTANCE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
